In consideration of the Releasees agreeing to the Maker's participation in the Makerspace Program, including the use of their facilities, supplies, equipment, tools, parking and other facilities, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Maker agrees for him/herself and his or her family member(s) under the age of 19 as follows:

WAIVER

1. TO WAIVE ANY AND ALL CLAIMS THAT THE MAKER HAS OR MAY HAVE IN THE FUTURE AGAINST THE RELEASEES AND TO RELEASE THE RELEASEES FROM any and all liability for any loss, damage, expense or injury, including death, that I/we may suffer or my next of kin may suffer as a result of the Maker's participation in the Makerspace Program DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT RSBC 1996 C 337 IN EFFECT FROM TIME TO TIME ON THE PART OF THE RELEASEES AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO

TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT THE MAKER FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN THE MAKERSPACE PROGRAM ACTIVITIES REFERRED TO ABOVE.

INDEMNITY

2. THE MAKER AGREES TO INDEMNIFY AND SAVE HARMLESS THE RELEASEES from any and all liability for any damage, loss, expense or injury to the Maker, a family member of the Maker or any third party, resulting from the Maker's participation in the Makerspace Program due to any cause whatsoever, including, but not limited to, negligence on the part of the Releasees, breach of contract by the Releasees, breach of any warranty by the Releasees in respect of design, manufacture, selection, installation, maintenance, adjustment of the equipment, tools or supplies (whether mine or the Releasees'), including any duty of care owed under the *Occupiers Liability Act RSBC 1996 c 303* in effect from time to time on the part of the Releasees and the failure of the Releasees to safeguard the Maker from the risks, damages and hazards of the Makerspace Program referred to above.

SAFETY

3. In entering into this Agreement, the Maker is not relying on any oral, visual or written representations or statements made by the Releasees with respect to the safety of the Makerspace Program other than what is set forth in this Agreement.

JURISDICTION

4. This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia and any litigation relating to this Agreement is within the exclusive jurisdiction of the Courts of British Columbia.

ENUREMENT

5. This Agreement shall be binding upon the Maker and his or her heirs, next of kin, executors, administrators, successors and assigns.
